USDA, et al., Civil Action No. 1:18-cv-03009, currently pending in the U.S. District Court for the District of Columbia. The Complaint, see first attachment, is based on the DFO's alleged failure to comply with the applicable time-limit provisions of the FOIA in response to Property of the People's (PoP's) request for records. In response to Item Nos. 1 and 2 of the request, see the second attachment, the Office of Contracting and Procurement, Procurement Services Division conducted a search for transaction data and correspondence in the USDA Credit Card Services Center (CCSC). The search incorporated the National Rifle Association (NRA) organizations, properties and conferences PoP provided as background material in its request. The CCSC search identified a spreadsheet which contains transactions that are responsive to PoP's request. These transactions reflect NRA-related purchases by the FS, NRCS, and APHIS. Please see the fifth attachment. Please be advised that charge card numbers will be redacted under Exemption 4 pursuant to DOJ-OIP's guidance titled Exemption 2 After the Supreme Court's Ruling in Milner v. Department of the Navy. Regarding Item No. 3, a query was submitted to the Farm Service Agency (FSA), Human Resources Division (HRD) regarding the system of records identified in your request as the Subsidiary Personnel, Pay and Travel Records System, USDA/FSA-11. The HRD staff informed the DFO that employee electronic personnel and time/attendance records are maintained in the Official Personnel Folders (eOPF) system and WebTA respectively. However, an electronic search for organizations or entities cannot be conducted in either of those systems since the systems are not set up for term or key word searches. In response to Item No. 4, an OCFO search was conducted by the Technical Innovation Services Division. The search located one (1) Financial Management Modernization Initiative spreadsheet that is responsive. The responsive spreadsheet reflects tracked agency funding associated with the NRA. Please see the fourth attachment. We intend to release this spreadsheet in full. Regarding Item Nos. 5 and 6 of PoP's request, searches were conducted by the OCFO, Travel Policy Team. The searches did not locate any records that are responsive to your request. The current E-Government Travel System (ETS2) only permits searches based on hotel stays and airline flight expenses. Since the Travel Policy Team is not able to search for specific vendor organizations in ETS2, the DFO will be unable to provide additional information regarding travel-related records. Lastly, the OCIO Departmental FOIA Office initiated a search with the OCIO's telecommunications provider, the Client Experience Center. This search was conducted in an effort to identify any electronic communications between USDA agency employees and the following e-mail addresses provided by PoP: 1. nraf@nrahq.org; 2. membership@nrahq.org; 3.
