

The Annual Report is attached. In addition, clarification regarding the listing of dolphins on form 7023 is below.

Mote currently houses two non-releaseable dolphins, a pan-tropical spotted dolphin and a spinner dolphin, under USDA license 58-C-0586. In addition, in cooperation with the NOAA Fisheries Service, Mote's Dolphin and Whale Hospital is involved with the rescue and rehabilitation of stranded cetaceans. All care and treatment during the temporary holding of these animals follows the guidelines as set forth under the Act. When these emergency medical situations arise, holding of an ill/injured animal is accomplished utilizing two quarantine pools. Within the past reporting period, October 1, 2005 – September 30, 2006, Mote has held four such stranded cetaceans for medical care (MML 0514A, 0514B, 0605, 0608).
