




RE: IACUC Approved Exceptions

The Valdosta State University IACUC has approved the following exception for the diurnal lighting schedule of hamsters used by [REDACTED] in his experimental protocol:

That hamsters used in experimental studies of circadian activity rhythms be kept under conditions of constant darkness for periods up to 1 month. This is necessary to examine endogenous rhythms that are not entrained by the environmental lighting cycle. In order to assess the effects of drugs on endogenous circadian phase, the hamsters must be allowed to free-run under constant lighting conditions, in this case, constant darkness.
