SPACE REQUIREMENTS.

Enclosures shall be constructed and maintained so as to provide sufficient space to allow each animal to make normal postural and social adjustments with adequate freedom of movement.

-Sows and gilts are kept individually in small gestation crates for at least one and a half months after they are bred. Animals can not turn around to make normal postural and social adjustments in these crates. Facility shall ensure that adequate space requirement is afforded to these animals.
