#### CITATION AND NOTIFICATION OF PENALTY

We believe that you violated the Animal Welfare Act (7 U.S.C. § 2131 et seq.) (AWA), as described below.

#### Date of Alleged Violation: March 4, 2015

9 C.F.R. § 3.19(b)(2) Handling. Any person handling a primary enclosure containing a dog or cat must use care and must avoid causing physical harm or distress to the dog or cat. ... A primary enclosure containing a dog or cat must not be tossed, dropped, or needlessly tilted, and must not be stacked in a manner that may reasonably be expected to result in its falling. It must be handled and positioned in the manner that written instructions and arrows on the outside of the primary enclosure indicate.

Delta accepted a cat (Maxwell) for transport in commerce from John Fitzgerald Kennedy Airport (JFK) via Flight DL 2364; to Hartsfield-Jackson Atlanta International Airport (ATL). Delta failed to handle Maxwell as carefully as possible in a manner that did not cause trauma, behavioral stress, physical harm, or unnecessary discomfort. Delta personnel did not use proper care when unloading Maxwell from Flight 2364. Maxwell's kennel fell from the belt loader causing the lid to crack, allowing Maxwell to escape. Consequently, a Delta Air Lines baggage tug struck/ran over and killed Maxwell.

The penalty for the alleged violation(s) described above is \$10,000.

The records shall include any offspring born of any animal while in his or her possession or under his or her control.

You failed to make, keep and maintain adequate records. You failed to properly record information on APHIS form 7005 or on cage cards, and record date of dispositions and buyer/receiver information on APHIS form 7006.

You failed to provide adequate veterinary care to prevent, control, diagnose and treat disease and injury. APHIS officials observed a male poodle with an overgrown and matted hair coat.

You failed to make, keep and maintain adequate records. You failed to properly record animal inventory, puppy births and acquisition information.

You failed to provide adequate veterinary care to prevent, control, diagnose and treat disease and injury. APHIS officials observed a male Welsh Corgi with overgrown nails.

A class "A" dealer (breeder) shall identify all live dogs and cats on the premises as follows: All live dogs and cats held on the premises, purchased, or otherwise acquired, sold or otherwise disposed of, or removed from the premises for delivery to a research facility or exhibitor or to another dealer, or for sale, through an auction sale or to any person for use as a pet, shall be identified by an official tag of the type described in section 2.51 affixed to the animal's neck by means of a collar made of material generally considered acceptable to pet owners as a means of identifying their pet dogs or cats, or shall be identified by a distinctive and legible tattoo marking acceptable to and approved by the Administrator.

You failed to provide identification for all live dogs on the premises. APHIS officials observed two female Pomeranians, one male Pomeranian/poodle mix, and two female Pomeranians/poodle mixes without identification.

- 2) One adult, female Pekinese with reddened gums and a hard, grayish-brown material on the surfaces of her front and cheek teeth, and,
- 3) One adult, female Pomeranian/Pekinese mix with reddened gums and a hard, grayish brown material on the surface of her front and cheek teeth, and,
- 4) One adult, male Welsh Corgi with overgrown toenails; and,
- 5) You were deworming the dogs and puppies at your facility with a product labeled for use in goats. You failed to consult an attending veterinarian on the appropriateness of using a product not labeled for use in dogs or puppies.

You failed to provide identification for all live dogs on the premises. You failed to properly identify twelve weaned puppies.

You failed to provide enclosures that were impervious to moisture. Several surfaces on the inside of the inside/outside building have areas of scratched and worn paint and some of the metal door flaps are rusted.

9 C.F.R. § 2.126(b) Access and inspection of records and property; submission of itineraries. The use of a room, table, or other facilities necessary for proper examination of the records and inspection of the property or animals must be extended to APHIS officials by the dealer, exhibitor, intermediate handler or carrier, and a responsible adult shall be made available to accompany APHIS officials during the inspection process.

You failed to have a responsible adult available to accompany APHIS officials during the inspection process.

9 C.F.R. § 3.125(a) Facilities, general. Structural strength. The facility must be constructed of such material and of such strength as appropriate for the animals involved. The temperature was measured at 35.6 degrees and two adult llamas in the shelter were shivering.

The hay was soiled and some of the animals were browsing for food at the feeding stations. The animals did not have any grain, mineral blocks, or vegetation available to them. The two feeding stations were used to feed four llamas, four goats, four sheep, and two camels.



The animals were in transit for a period of time in excess of 30 hours, and the shipping container was not opened to visually observe the animals until it was delivered to the consignee and she opened it. possession or under his or her control, or which is transported, sold, euthanized, or otherwise disposed of by that dealer or exhibitor. The records shall include any offspring born of any animal while in his or her possession or under his or her control.

You failed to provide a record of disposition for a wolf hybrid.

# Date of Alleged Violation: (b) (6), (b) 2015

9 C.F.R. § 3.56(b)(1) Sanitation: sanitation of primary enclosures: Primary enclosures for rabbits shall be sanitized at least once every 30 days in the

Primary enclosures for rabbits shall be sanifized at least once every 30 days in the manner provided in paragraph (b)(3) of this section.

You failed to properly sanitize the primary rabbit enclosure that had excessively wet bedding, two rabbit shelters with significantly chewed edges, areas of chewed wood on the interior of the shelters, and the back wall that was warped inward.

- 2. A ten-year-old male ring-tailed lemur that was and an inward curled first digit on its hand.




