B.2 CEILING PRICE FOR REMEDIAL MAINTENANCE

Contracting Officer's Representative (COR) approval is required prior to Contractor's personnel making any repair which will cost more than \$1000 for labor and parts.

B.3 PREVIOUS PROCUREMENT HISTORY

The previous contract for subject services was awarded to Aloha Airlines on 6/8/98. The price was \$568.73 per preventative maintenance visit based on 8 hours per visit and 71.20 per hour for remedial maintenance for equipment for the year ending June 30, 2001.

*Note: This effort is being priced per hour. The previous contract was priced per job.

SECTION C - DESCRIPTION/SPECIFICATIONS/WORK STATEMENT

C.1 SCOPE OF WORK

The USDA, Animal & Plant Health Inspection Service (APHIS), Plant Protection & Quarantine (PPQ), Honolulu, Hawaii requires preventive and remedial maintenance service for thirty-four (34) X-ray baggage scanners located at seven airports in the State of Hawaii.

Preventive maintenance shall be performed on all systems in April and September of each year during the performance of the contract.

Remedial maintenance shall be as requested by the Government.

Maintenance service calls must be coordinated with the Port Director or designee, such as the start and end of the call. A service call report for all maintenance must be submitted upon completion of the service with the date, nature of the call, name of technician, location and serial number of the machine, service time and parts replaced. These reports must be signed by the Port Director or designee for approval and will be used as authorization for payment. All replaced parts are government property and must be appropriately inventoried. Disposition of the item will be decided by the Port Director or designee. Written approval from the Port Director or designee to exchange parts between machines must be accomplished before initiation. In addition, the part must be reinstalled immediately upon completion of the service call and the Port Director or designee notified.

Travel, labor, parts, freight, and material handling expenses shall be invoiced separately and supporting documentation provided. The actual cost will be paid for all replacement parts and travel and related costs. The commuter travel time will be paid at actual travel time not to exceed 2 hours.

Technician must be initially factory trained and are required to complete a refresher course once a year.

C.2 PREVENTIVE MAINTENANCE

Contractor shall perform preventive maintenance in April and September of each year. Contractor shall follow manufacturer's servicing manuals. Preventative maintenance shall be paid at the hourly rate stated in Section B. The hourly labor rate shall be the same for all seven (7) airport locations. Contractor shall invoice upon completion of the preventive maintenance service.

Preventive maintenance shall include, but is not limited to, verification of radiation safety, detection and correction of wear and detection of possible degradation of electronic components.

Maintenance shall also include the following:

1. Vacuum interior and exterior of baggage scanner system(s) and fan filters if required
2. Lubricate high power probe
3. Touch-up of painted areas
4. Radiation Safety:
 - measure dose to parcel
 - measure radiation leakage
 - check "System On" indicators
 - check "X-ray On" indicators
 - check condition of lead curtains
 - check functioning of all panels' interlocks and foot mat
5. Mechanical:
 - check & lubricate conveyor rollers and gear box
 - check condition of conveyor belt & lacing
 - check conveyor belt condition, tension, tracking and lacing
 - check condition of sensor dust shield
 - check generator oil levels and any leaks
 - check optical sense module alignment.

6. Electronic:
 - check and record X-ray tube current mA and voltage KV
 - check control panel switches
 - check TV monitor adjustment
 - inspect conveyor relays
 - check DVS power supply voltage
 - check inspection cycle timing
 - check image quality, by using a step wedge, and collimator alignment
 - check wires on back rollers
 - check terminals for proper groundings
 - check cables, internal and external, for any damage
 - check the operating system
7. Perform radiation survey and complete FAA Form 1650-17 "X-Ray Systems Radiation Leakage Report" or an acceptable equivalent.

NOTE: THIS SURVEY IS TO BE PERFORMED DURING THE FIRST PREVENTIVE MAINTENANCE VISIT, AND YEARLY THEREAFTER FOR ANY OPTION YEARS OF THE CONTRACT. A COPY OF THE REPORT IS TO BE PROVIDED WITHIN 10 DAYS AFTER THE SURVEY TO THE CONTRACTING OFFICER AND TO THE CONTRACTING OFFICER' S REPRESENTATIVE.

C.3 REMEDIAL MAINTENANCE

Remedial maintenance personnel shall be on-site within 24 hours after request by the Government. Any deviation from the 24 hour response time must be approved by the COR.

Remedial maintenance labor shall be paid at the hourly rate stated in Section B. The hourly labor rate shall be the same for all seven (7) airport locations. All maintenance shall be performed during the hours of operation of the Port with the machine being serviced. Unless approved in advance by the Port Director or designee, only one technician should be used for remedial maintenance.

Overtime is not expected on this contract. The remedial and preventative maintenance should take place during regular business hours. Should overtime be required, it must be approved in advance in writing by the COR and will be based on the needs of the Government.

(2) The Government may reject any or all proposals if such action is in the Government's interest.

(3) The Government may waive informalities and minor irregularities in proposals received.

(4) The Government intends to evaluate proposals and award a contract after conducting discussions with offerors whose proposals have been determined to be within the competitive range. If the Contracting Officer determines that the number of proposals that would otherwise be in the competitive range exceeds the number at which an efficient competition can be conducted, the Contracting Officer may limit the number of proposals in the competitive range to the greatest number that will permit an efficient competition among the most highly

rated proposals. Therefore, the offeror's initial proposal should contain the offeror's best terms from a price and technical standpoint.

- (5) The Government reserves the right to make an award on any item for a quantity less than the quantity offered, at the unit cost or prices offered, unless the offeror specifies otherwise in the proposal.
- (6) The Government reserves the right to make multiple awards if, after considering the additional administrative costs, it is in the Government's best interest to do so.
- (7) Exchanges with offerors after receipt of a proposal do not constitute a rejection or counteroffer by the Government.
- (8) The Government may determine that a proposal is unacceptable if the prices proposed are materially unbalanced between line items or subline items. Unbalanced pricing exists when, despite an acceptable total evaluated price, the price of one or more contract line items is significantly overstated or understated as indicated by the application of cost or price analysis techniques. A proposal may be rejected if the Contracting Officer determines that the lack of balance poses an unacceptable risk to the Government.
- (9) If a cost realism analysis is performed, cost realism may be considered by the source selection authority in evaluating performance or schedule risk.
- (10) A written award or acceptance of proposal mailed or otherwise furnished to the successful offeror within the time specified in the proposal shall result in a binding contract without further action by either party.
- (11) The Government may disclose the following information in postaward debriefings to other offerors:
 - (i) The overall evaluated cost or price and technical rating of the successful offeror;
 - (ii) The overall ranking of all offerors, when any ranking was developed by the agency during source selection;
 - (iii) A summary of the rationale for award; and
 - (iv) For acquisitions of commercial items, the make and model of the item to be delivered by the successful offeror.

L.3 52.215-5 FACSIMILE PROPOSALS (OCT 1997)

- (a) Definition. Facsimile proposal, as used in this provision, means a proposal, revision or modification of a proposal, or withdrawal of a proposal that is transmitted to and received by the Government via facsimile machine.
- (b) Offerors may submit facsimile proposals as responses to this solicitation. Facsimile proposals are subject to the same rules as paper proposals.

 - (3) The resubmission shall be considered as if it were received at the date and time of the original unreadable submission for the purpose of determining timeliness, provided the offeror complies with the time and format requirements for resubmission prescribed by the Contracting Officer.
- (e) The Government reserves the right to make award solely on the facsimile proposal. However, if requested to do so by the Contracting Officer, the apparently successful offeror promptly shall submit the complete original signed proposal.

- (a) The Government will award a contract resulting from this solicitation to the responsible offeror whose offer conforming to the solicitation will be most advantageous to the Government, price and other factors considered. The following factors shall be used to evaluate offers:

technical capability, past performance, price
