1. The United States is free from foot-and-mouth disease, rinderpest, contagious bovine pleuropneumonia, lumpy skin disease, bovine piroplasmosis (babesiosis) trypanosomiasis, and theileriasis (<u>T. Parva</u> and <u>T. Annulata</u>.)

2. The donor bull named herein from which the semen has been collected, has remained in the United States for more than 6 months before the collection of the semen for export to Egypt.

3. At the time of collection of semen for export to Egypt, the donor bull and all other animals in contact were free from clinical symptoms of all infectious diseases.

4. The semen for export to Egypt was collected and processed under the supervision of a USDAaccredited veterinarian.

5. The diluent used for processing the semen for export to Egypt is known to be free from agents of animal infectious diseases.

6. There has been no case of anaplasmosis in the AI center for the last 3 years prior to collection of the semen for export to Egypt.

7. The AI center, has not had any clinical cases or virus isolation of bluetongue, bovine viral
