

Mexico - Important information regarding trade bans and other restrictions

Poultry products:

High Pathogenicity Avian Influenza (HPAI):

- Restricted area (s):
 - The state of **Colorado** unless the product is processed in accordance with the parameters on the export certificate. Effective date: March 22, 2022.
 - The state of **Delaware** unless the product is processed in accordance with the parameters on the export certificate. Effective date: January 25, 2022.
 - The state of **Indiana** unless the product is processed in accordance with the parameters on the export certificate. Effective date: January 11, 2022.
 - The state of **Iowa** unless the product is processed in accordance with the parameters on the export certificate. Effective date: February 6, 2022.
 - The state of **Kansas** unless the product is processed in accordance with the parameters on the export certificate. Effective date: March 16, 2022.
 - The state of **Kentucky** unless the product is processed in accordance with the parameters on the export certificate. Effective date: January 17, 2022.

Poultry products:

High Pathogenicity Avian Influenza (HPAI):

The following products produced during the dates indicated below are ineligible for export to Mexico from the following regions if they have not been treated as indicated in the export certificate. Refer to the locations and dates listed below.

Animal feeds and food: Additives, Complements and Supplements for Animal Feeding

- Restricted area: The entire United States unless the product is processed in accordance with the parameters on the export certificate. Effective date: On or after April 8, 2020 and before October 27, 2020.

Animal feeds and food: Balanced animal feeds (not including dogs and cats)

- Restricted area: The entire United States unless the product is processed in accordance with the parameters on the export certificate. Effective date: On or after April 8, 2020 and before October 27, 2020.

Animal feeds and food: Balanced pet foods for dogs and cats

- Restricted area: The entire United States unless the product is processed in accordance with the parameters on the export certificate. Effective date: On or after April 8, 2020 and before October 27, 2020.

Hides and skins: Salted Ostrich Hides and Skins for Manufacturing Purposes

- Restricted area:
 - South Carolina: The **10km radius zone** surrounding the affected premises in Chesterfield County, South Carolina. Effective date is noted on the map.
 - North Carolina: The **10km radius zone** surrounding the affected premises in Union County and Anson County, North Carolina. Effective date is noted on the map.

Low Pathogenicity Avian Influenza (LPAI):

The following counties are restricted for the following IREG:

Hides and skins: Salted Ostrich Hides and Skins for Manufacturing Purposes

California

- a. Monterey County on or after April 20, 2019 and on or before September 18, 2019
- b. Merced County on or after June 27, 2019 and on or before January 15, 2020;
- c. Stanislaus County on or after August 18, 2018 and on or before July 29, 2019;

Connecticut

- a. Fairfield County on or after March 29, 2019 and on or before July 7, 2019

Pennsylvania

- a. Lancaster County on or after March 13, 2019 and on or before August 8, 2019

North Carolina

- a. Union County on or after March 12, 2020 and before October 27, 2020.
- b. Anson County on or after March 12, 2020 and before October 27, 2020.

South Carolina

- a. Chesterfield County on or after March 17, 2020 and before October 27, 2020.

Newcastle Disease:

Due to cases of virulent Newcastle disease in California, the following products produced during the dates indicated below are ineligible for export to Mexico from the following regions if they have not been treated as indicated in the export certificate.

Hides and skins: Salted Ostrich Hides and Skins for Manufacturing Purposes

Restricted Area: State of California – effective May 17, 2018

Food preparations containing animal products for human consumption If they contain poultry meat products (raw or heat treated).

Restricted Area:

- California
 - A. Poultry and poultry products originating from Los Angeles County, California on or after September 25, 2018 are ineligible.
 - B. Poultry and poultry products originating from San Bernardino County, California, on or after May 24, 2018 are ineligible.
 - C. Poultry and poultry products originating from Riverside County, California, on or after June 30, 2018 are ineligible.
 - D. Poultry and poultry products originating from Ventura County, California, on or after August 15, 2018 and on or before August 5, 2019 are ineligible.
- Utah
 - A. Poultry and poultry products originating from Utah County, Utah on or after January 17, 2019 and on or before August 18, 2019 are ineligible.
- Arizona
 - A. Coconino County on or after April 1, 2019 and on or before November 10, 2019 are ineligible

Animal feeds and food: Additives, Complements and Supplements for Animal Feeding

- Restricted area: The entire United States unless the product is processed in accordance with the parameters on the export certificate. Effective date: April 8, 2020

Animal feeds and food: Balanced animal feeds (not including dogs and cats)

- Restricted area: The entire United States unless the product is processed in accordance with the parameters on the export certificate. Effective date: April 8, 2020

Animal feeds and food: Balanced pet foods for dogs and cats

- Restricted area: The entire United States unless the product is processed in accordance with the parameters on the export certificate. Effective date: April 8, 2020

Rabbit products:

Mexico SENASICA advised on April 23, 2010, that until further notice, animal products from rabbits are restricted unless they have received an appropriate treatment to inactivate rabbit hemorrhagic disease virus.
