2012 SUMMARY OF WEST NILE VIRUS EQUINE CASES IN THE UNITED STATES

This report is a descriptive summary of U.S. equine West Nile virus (WNV) cases reported to the United States Department of Agriculture (USDA) in 2012. The USDA Animal and Plant Health Inspection Service (APHIS) Veterinary Services (VS) collaborates with the Centers for Disease Control and Prevention (CDC) and State veterinary and public health officials to facilitate communication about arbovirus disease cases in horses and confirm equine cases in each State. CDC collects arbovirus case information using its ArboNET reporting system, an electronic surveillance and reporting system used to track and report arboviral activity in humans and animals. During the transmission season, VS disseminates the equine case information to State animal health officials for confirmation and posts the number of confirmed cases to the USDA equine health Web site (http://www.aphis.usda.gov/vs/nahss/equine/). Specific case definitions are also provided on this site. In this document, 'reported cases' of WNV may include presumptive positive and confirmed positive cases.




Figure 1. Reported U.S. equine cases of West Nile virus, 2001-2012




Figure 2. Distribution of reported equine WNV cases in 2012 (627 total cases)




Figure 3. U.S. distribution of 87 reported equine West Nile virus cases in 2011

In 2012, **627** equine cases of WNV were reported from **41** States. This was the highest number of equine cases of WNV reported in the United States in the past 5 years, but still considerably lower than the number of cases reported during the 2002 WNV outbreak when 15,257 equine cases were reported (Figure 1). The higher number of equine WNV cases in 2012 was concurrent with an increase in human WNV cases in 2012. Figure 1 shows the annual number of equine WNV cases reported in the United States from 2001 through 2012. Figure 2 shows the number of equine WNV cases in each State in 2012, and Table 1 provides the number of cases per county or parish in those States in 2012. The maps in Figures 3-15 show the historic number of equine WNV cases reported in each State from 1999 through 2011.




Figure 4. U.S. distribution of 125 reported equine West Nile virus cases in 2010




Figure 5. U.S. distribution of 276 reported equine West Nile virus cases in 2009




Figure 6. U.S. distribution of 179 reported equine West Nile virus cases in 2008




Figure 7. U.S. distribution of 468 reported equine West Nile virus cases in 2007




Figure 8. U.S. distribution of 1,086 reported equine West Nile virus cases in 2006




Figure 9. U.S. distribution of 1,088 reported equine West Nile virus cases in 2005




Figure 10. U.S. distribution of 1,406 reported equine West Nile virus cases in 2004




Figure 11. U.S. distribution of 5,181 reported equine West Nile virus cases in 2003




Figure 12. U.S. distribution of 15,257 reported equine West Nile virus cases in 2002




Figure 13. U.S. distribution of 738 reported equine West Nile virus cases in 2001




Figure 14. U.S. State distribution of 60 reported equine West Nile virus cases in 2000




Figure 15. U.S. distribution of 25 reported equine West Nile virus cases in 1999
