## Potential Disinfectants to Use Against SVCV and TiLV

This table is meant to assist persons in finding U.S. Environmental Protection Agency (EPA)-registered disinfectants that may be used against spring viremia of carp virus (SVCV) and tilapia lake virus (TiLV). The National Pesticide Information Retrieval System (NPIRS®)<sup>1</sup> indicates there are no disinfectants registered under Federal Insecticide, Fungicide, and Rodenticide Act (FIFRA) section 3 (see EPA's description of FIFRA section 3 registrations at

https://www3.epa.gov/pesticides/regulating/section18 training/module-

<u>01/Section%203%20Registration.pdf</u>) for use against SVCV or TiLV. Therefore, the United States Department of Agriculture (USDA) Animal and Plant Health Inspection Service (APHIS) recommends applicators find products that are permitted for use against SVCV or TiLV under FIFRA section 2(ee)(2)<sup>2</sup> (see EPA's description of FIFRA section 2(ee) recommendations at <u>Section 2ee.pdf (epa.gov)</u>). Applicators may legally apply registered disinfectant products against any pest provided that the applicable use sites (e.g., aquaculture equipment) are listed on the product label and that all applicable label use directions and safety precautions are followed.

USDA APHIS expects the below list of products obtained from NPIRS® on June 14, 2021 to be efficacious against SVCV and TiLV. The list may not be an all-inclusive list of appropriate EPA-registered disinfectants. The inclusion of any product on this table does not imply endorsement of the product by USDA APHIS.

EPA-registered labels can be found on EPA's Pesticide Product Label System (PPLS)<sup>3</sup> at <a href="https://iaspub.epa.gov/apex/pesticides/f?p=PPLS:1">https://iaspub.epa.gov/apex/pesticides/f?p=PPLS:1</a>. EPA-registered labels are often identical to the labels appearing on the container; however, states may approve alternate language that differs from EPA's label. Please use the below table as a first step to identify a potential EPA-registered disinfectant to use against SVCV and/or TiLV, then locate the appropriate container label within the appropriate state at the following website <a href="http://npirspublic.ceris.purdue.edu/state/">http://npirspublic.ceris.purdue.edu/state/</a> to verify all appropriate use sites are on the container label. Additionally, check with the appropriate state department of agriculture (or other appropriate state agency that regulates pesticides) to determine if the agency needs to be alerted to FIFRA 2(ee) uses.

The NPIRS\* obtains product information monthly from the EPA Pesticide Product Information System (PPIS) website. This PPIS information, including registered use sites and pests listed on the EPA stamped approved label, is disseminated through the NPIRS\* member and public websites and is provided for informational purposes only. <sup>&</sup>lt;sup>2</sup> FIFRA section 2(ee)(2): "TO USE ANY REGISTERED PESTICIDE IN A MANNER INCONSISTENT WITH ITS LABELING.—The term 'to use any registered pesticide in a manner inconsistent with its labeling' means to use any registered pesticide in a manner not permitted by the labeling, except that the term shall not include ...(2) applying a pesticide against any target pest not specified on the labeling if the application is to the crop, animal, or site specified on the labeling, unless the Administrator has required that the labeling specifically state that the pesticide may be used only for the pests specified on the labeling after the Administrator has determined that the use of the pesticide against other pests would cause an unreasonable adverse effect on the environment,..."
