Category E Explanation

The Category E dogs were used on an Absorption, Distribution, Metabolism, Elimination, and Pharmacokinetics Study of a New Molecular Entity for a Pharmaceutical Sponsor. The protocol anticipated that the new molecular entity would not involve pain and distress to the dogs (Category C), however, one dog was found dead over a weekend and another dog needed to be humanely euthanized after aspirating a dose.
