The cats were challenged with feline calicivirus in order to produce reagent challenge virus for testing of veterinary biologicals according to 9CFR 113.314(c)(3).

Infection of the host is necessary to maintain the virulence of the feline calicivirus. The production of a virulent feline calicivirus by this in vivo method relies on the development of the infectious process with out any treatment for alleviating stress.
