Exceptions to the exercise plan for dogs

A total of 35 dogs were housed in metabolic cages during the fiscal year. These animals are exempted from the canine exercise program. Metabolism dogs are chronically catheterized and continuously, consciously monitored via computer. The jacket system precludes large caging in order to minimize problems with the various instrumentation. The exemption from the exercise requirement has been approved by the University of Mississippi Medical Center's IACUC and verified by the LAF veterinary staff.
