Exceptions to standard housing are routinely done postoperatively. Dogs are routinely housed in recovery cages with a floor surface area of 15 ft<sup>2</sup> in a designated postoperative recovery room for 2-4 days to one week after surgery. Animals are checked two or more times a day as often as needed. Dogs are taken out of the recovery cage to urinate and defecate and to move around the room as their condition allows.

This exception applies to all dogs which have recovery surgery and includes all 28 dogs.

The IACUC has approved this exception.
