*On May 25, 2016, the United States District Court for the Northern District of Georgia issued a preliminary injunction that stated: "Defendants are hereby ENJOINED from disqualifying Plaintiffs' horse, Honors, under the Scar Rule without providing Plaintiffs with adequate pre-deprivation process, including notice and the opportunity to be heard." McSwain v. Vilsack, Civ. No. 1:16-cv-01234-RWS (N.D. Ga). Consequently, APHIS did not notify the management of the Christmas In July Horse Show and TWH National Celebration of its results of its compliance inspections of the horse "Honors," and we have marked the above results that exclude inspection results involving "Honors" with an asterisk.
