ATTENDING VETERINARIAN AND ADEQUATE VETERINARY CARE (DEALERS AND EXHIBITORS).

Sec. 2.40 Attending veterinarian and adequate veterinary care (dealers and exhibitors).

(Also refer to Policy 3, Veterinary Care) (a) Each dealer or exhibitor shall have an attending veterinarian who shall provide adequate veterinary care to its animals in compliance with this section. (2) Each dealer and exhibitor shall assure that the attending veterinarian has appropriate authority to ensure the provision of adequate veterinary care and to oversee the adequacy of other aspects of animal care and use.

The attending veterinarian does not have complete program authority. The owner with objections of the attending veterinarian may make decisions relating to animal welfare. The facility has began addressing this issue and is in the process of establishing guidelines and committees to give the veterinarian the necessary authority to ensure provisions of adequate veterinary care and to oversee the adequacy of other aspects of animal care and use.

HANDLING OF ANIMALS.

(b)(1) During public exhibition, any animal must be handled so there is minimal risk of harm to the animal and to the public, with sufficient distance and/or barriers between the animal and the general viewing public so as to assure the safety of animals and the public.

The serval enclosure does not have sufficient barriers on the back side of the exhibit. The back portion of this exhibit is adjacent to the onsite lodging houses. Since individuals that are staying in the lodging facility have to walk near the enclosure when exiting the home, a barrier should be in place for their and the animals protection.

HOUSING FACILITIES, GENERAL.

(a) Structure: construction. Housing facilities for nonhuman primates must be designed and constructed so that they are structurally sound for the species of nonhuman primates housed in them. They must be kept in good repair, and they must protect the animals from injury, contain the animals securely, and restrict other animals from entering.

(INSPECTION REPORT)

The lemur exhibit has a fence netting that has been in place for approximately 8 years. This netting has caused injury to 4 animals that have been housed in the enclosure. One animal has a permanent nerve damage to his arm, another has had a finger amputated after being caught, and one other digit injury as a result of being caught. The facility has discussed replacing the netting but it has not began the process.

Correct by August 1, 2004. Replace this netting to prevent animal injury in the future.
