Measures shall be taken to prevent the wetting of rabbits in such enclosures if a washing process is used.

*** The primary enclosure for animal # M2A9 has large accumulation of animal waste; the toy that is provided for the animal was contaminated with animal excreta. Removal of animal waste should be done frequent enough to prevent health problems.

PRIMARY ENCLOSURES.

*** In room # 3505 there are two cages that have about 2 square inches holes that have sharp edges that could cause injury to the animals.
Corrected during the inspection.

*** One of the outdoors enclosures in the farm has three plastic drums that are used as enrichment devices, the drums are connected together by large nails that are protruding inside the drums and could cause injury to the animals.

 - (iii) Contain the nonhuman primates securely

*** In room # 434C it was noticed that two of the primates cages are not secured, the cages were rolled away from the walls, and both cages were very close to each other, this situation may subject the animals to unnecessary stress if these animals are not compatible, and may result in animal injury if any of the animals started to fight, also the water coil could break and disrupt the water supply for the affected animal.

 - (ii) Protect the nonhuman primates from injury

*** The primary enclosure for animal # MOO929 has a long chain (about 15 inches) hanging from the top of the cage, this chain could cause the animal to be hurt if the animal accidentally has the chain wrapped around his neck.

(i) The minimum space that must be provided to each nonhuman primate, whether housed individually or with other nonhuman primates, will be determined by the typical weight of animals of its species, except for brachiating species and great apes and will be calculated by using the following table:

*** The following animals were housed in cages that don't meet the minimum requirement for floor space; animal # 124251 weights 26.3 kgm, animal # 15348 weights 27.21 kgm, and animal # 16228 weights 29.57 kgm. All previous animals are housed in cages that provide floor space of 6.39 square feet each. Animals should be provided with floor space as per table above.

CLEANING, SANITIZATION, HOUSEKEEPING, AND PEST CONTROL.

(a)Cleaning of primary enclosures. Excreta and food waste must be removed from inside each indoor primary enclosure daily and from underneath them as often as necessary to prevent an excessive accumulation of feces and food waste, to prevent the nonhuman primates from becoming soiled, and to reduce disease hazards, insects, pests, and odors.

*** In room # 434B it was noticed that there is accumulation of animal waste underneath one of the cages, it appears that the floor was cleaned but the cleaning didn't include removing the animal waste from underneath the cage. Removal of animal waste during the cleaning process will help reducing propagation of organism and protect the animal health.

(c) Housekeeping for premises. Premises where housing facilities are located, including buildings and surrounding grounds, must be kept clean and in good repair in order to protect the nonhuman primates from injury, to facilitate the husbandry practices required in this subpart, and to reduce or eliminate breeding and living areas for rodents, pests, and vermin

*** In room 434, it was noticed that the air vent was covered with pieces of peeling paint. Peeling paint should be scrubbed and collected so it doesn't circulate in the air.

*** The inside enclosures for the animals in building # 13 have walls that have peeling paint. The surfaces that come in contact with the animals need to be repainted or sealed so it can be cleaned and sanitized.

*** The inside enclosures for the animals in building 11 have perches that lost their paint coat and in need of repair, so it can be readily be cleaned and sanitized.

Correct by: 6/4

*** Room # 812 has peeling paint from the walls; the debris from the peeling paint is present on the floors. The walls and floors must be kept clean.
