Dear Mr. Cable:

Thank you for your letter dated July 19, 2021 (21-161-01cr) requesting confirmation that your plants are exempt from regulation pursuant to 7 CFR § 340.1(c)(2). Your letter describes three petunia (*Petunia* x *hybrida*) varieties ((40257 (Potunia Plus Papaya), 40537 (Fortunia Red), and 40794 (Surprise Red)) modified for altered flower color.

The Plant Protection Act of 2000 (PPA) provides USDA with broad authority to protect U.S. agriculture, the environment, and the economy by, among other things, regulating the movement of plants and articles to prevent the introduction or dissemination of a plant pest within the United States. As such, USDA, through the Animal and Plant Health Inspection Service, regulates the "Movement of Organisms Modified or Produced through Genetic Engineering," as described in 7 CFR part 340. These regulations do not apply to plants that contain a modification of a type listed in § 340.1(b) or § 340.1(c).

In your letter you represent, with supporting data, that your petunias descend from previously modified petunias containing both of the following plant-trait-mechanism of action (PTMOA) combinations: petunia with altered flower color via the maize AI gene encoding dihydroflavonol 4-reductase (DFR) and petunia with antibiotic resistance via neomycin phosphotransferase (NPTII). You also represent that petunia varieties with these same PTMOAs, descending from the same previously modified petunias, have been determined by USDA not to be regulated under 7 CFR part 340 (petition 19-099-01p).

Based on our review of the representations made in your letter, USDA confirms that the three petunia varieties modified to include the maize A1-DFR and nptII genes meet the exemption described in § 340.1(c)(2) and are exempt from regulation under 7 CFR part 340. Plants with modifications that are exempt pursuant to § 340.1(c)(2) are unlikely to pose an increased plant pest risk compared to previous plants containing a PTMOA combination(s) that USDA has determined to not be regulated.

Although your petunias are not regulated under 7 CFR part 340, they may be subject to other USDA regulations or other regulatory authorities. For example, importation of your plants or their seeds, may be subject to Plant Protection and Quarantine (PPQ) permit and/or quarantine requirements.
