## **Travel Requirements Based on Pet Type**

Carefully read ALL of the requirements related to your pet on this page.

- This page provides the most recent entry requirements and can change without notice.
- It is the responsibility of the veterinarian to make sure the pet has met all health requirements of the destination country before issuing a health certificate.
- Failure to meet the requirements may result in problems gaining certificate endorsement or difficulties upon arrival in the destination country.
- Health certificates must be legible, accurate, and complete.

## **Dogs and Cats**

• An APHIS endorsed international health certificate is not required.

- Dogs and cats must be vaccinated against rabies and must travel to French Guyana with a valid rabies vaccination certificate signed by a licensed veterinarian.
- The rabies vaccination must be given either:
  - Within 30 days of travel for adult animals that did not have a lapse in their rabies vaccine coverage; or
  - More than 30 days before travel for adult animals that had a lapse between rabies booster vaccinations; or
  - More than 30 days before travel for animals vaccinated for the first time prior to travel;
- Each family is limited to three animals.
  - Of the three animals, only one can be a puppy or kitten under 6 months of age;
- If your dog or cat cannot meet the conditions above, please contact <u>French</u> Guyana offices to determine if the pet is eligible to travel.

## **Birds**

- An APHIS endorsed international health certificate is not required.
- Pet birds must travel with the following documents:
  - $\circ\,$  A health certificate signed by a licensed veterinarian.
    - No specific health certificate format is required.
  - A written and signed statement from the pet bird owner stating they will not sell the bird(s). The pet bird owner is responsible for providing this document.
- Each family is limited to two birds for psittacine species (parrots) and ten birds for small species.

## **Reptiles**

- Pet reptiles must travel with a health certificate issued by a USDA Accredited Veterinarian within 5 days of departure from the U.S.
  - APHIS endorsement of the health certificate is not required.

- Each family is limited to two reptiles;
- The animals are not to be sold under any circumstances;

## **Rabbits**

- Pet rabbits must travel with a health certificate issued by a USDA Accredited Veterinarian within 5 days of departure from the U.S.
  - APHIS endorsement of the health certificate is not required
- The rabbits must have resided in the United States for at least 21 consecutive days immediately prior to issuance of the certificate.
- Each family is limited to **three** rabbits.

## **Rodents**

- Rodents include, but are not limited to: mice, rats, hamsters, gerbils, and guinea pigs.
- Pet rodents must travel with a health certificate issued by a USDA Accredited
   Veterinarian within 5 days of departure from the U.S.
  - o APHIS endorsement of the health certificate is not required
- The animals must have resided in the United States for at least 21 consecutive days immediately prior to issuance of the certificate.
- Each family is limited to three rodents.

## **Other Pets**

For pet travel requirements not listed, APHIS has not been officially informed by the foreign country about the requirements for your pet's travel. We recommend that you contact a government official of the country you are traveling to for more information.

#### Considerations for airline travel and cruises:



Airlines and shipping lines have their own policies and requirements for transporting pets. Check with your airline or shipping representative to determine what requirements they may have.

<sup>\*</sup> Northern Ireland is part of the United Kingdom (UK), but will continue to follow European Union (EU) requirements even though the UK is no longer part of the EU.

<sup>\*\*</sup> Norway and Switzerland are **not** part of the EU but have adopted EU legislation for import of most species of live animals.

#### View APHIS Requirements

**ALERT:** If you're traveling with a dog, be aware that the <u>CDC has additional</u> requirements for bringing a dog into the <u>United States</u>. You must follow CDC's requirements, or your dog will not be allowed to enter the <u>United States</u>.

#### If you are transiting (passing through) the European Union:



If your pet is traveling through (transiting) a country in the European Union (EU) on the way to a third, non-EU country, you will also need a transit health certificate for your pet for the EU. The transit health certificate will be the same as if your pet's final destination was the EU country.
