## **Travel Requirements Based on Pet Type**

- Failure to meet the requirements may result in problems gaining certificate endorsement or difficulties upon arrival in the destination country.
- Health certificates must be legible, accurate, and complete.

## STEP 1. Required vaccinations

Your pet must receive a rabies vaccination within 12 months prior to arrival in Grenada.

Consult the import permit application for dogs and make sure your pets comply with any **additionally required** vaccines (see **Step 3** below for import permit application link).

## STEP 2. International Health Certificate

Grenada requires an International Health Certificate issued by a USDA Accredited Veterinarian and endorsed by APHIS. The health certificate **must be** issued by your veterinarian no earlier than 3 weeks prior to your scheduled arrival in Grenada. Note: obtaining a health certificate too close to the date of scheduled arrival in Grenada may not allow adequate processing time for your import permit application in Step 3.

This certificate may be generated and submitted to APHIS for endorsement by your veterinarian online using <u>VEHCS</u>. (preferred method)

# STEP 3. Apply for an Import Permit

# STEP 1. Required vaccinations

Your pet must receive a rabies vaccination within 12 months prior to arrival in Grenada.

Consult the import permit application for cats and make sure your pets comply with any **additionally required** vaccines (see **Step 3** below for import permit application link).

## STEP 2. International Health Certificate

Grenada requires an International Health Certificate issued by a USDA Accredited Veterinarian and endorsed by APHIS. #### Considerations for airline travel and cruises:



Airlines and shipping lines have their own policies and requirements for transporting pets. Check with your airline or shipping representative to determine what requirements they may have.

**ALERT:** If you're traveling with a dog, be aware that the <u>CDC has additional</u>

<u>requirements for bringing a dog into the United States</u>. You must follow CDC's requirements, or your dog will not be allowed to enter the United States.

## If you are transiting (passing through) the European Union:



If your pet is traveling through (transiting) a country in the European Union (EU) on the way to a third, non-EU country, you will also need a transit health certificate for your pet for the EU. The transit health certificate will be the same as if your pet's final destination was the EU country. Use the information and steps above under "Travel Requirements Based on Pet Type" to determine which health certificate should be used. View a list of EU countries.
