

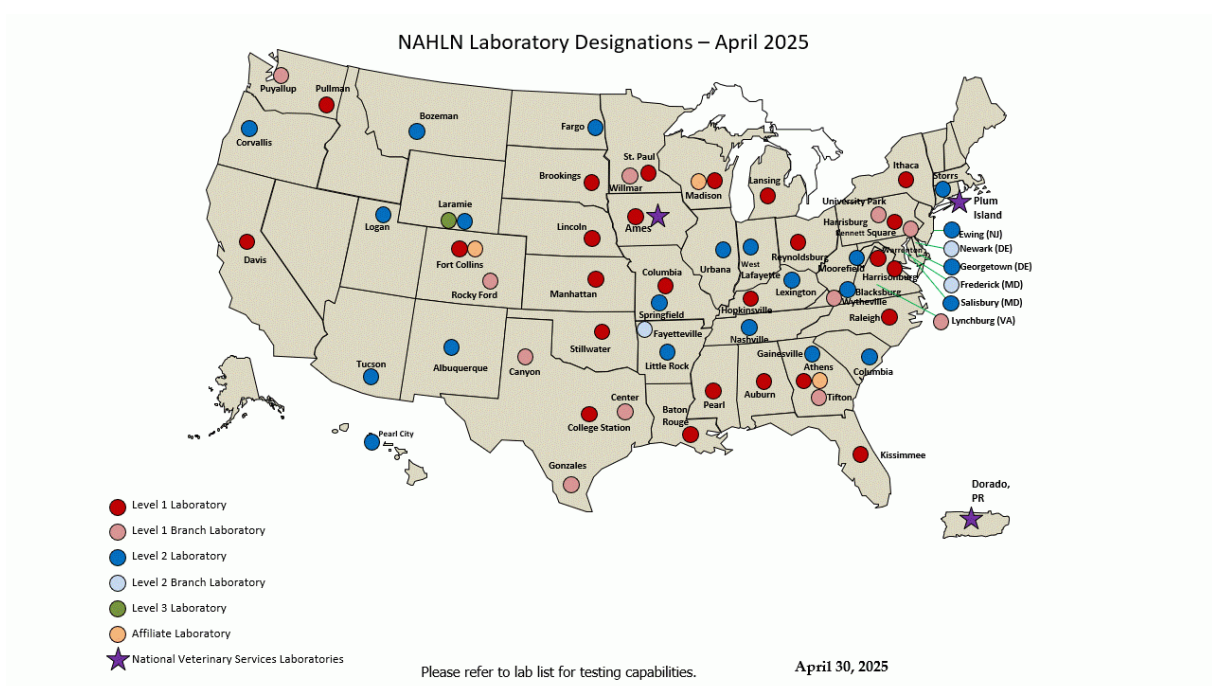

NAHLN Testing Requirements for Commercially Available Products

Information for commercial manufacturers of reagents and testing platforms on minimum validation requirements for acceptance into the NAHLN. Additional approvals by the [NVSL](#), VS' [Center for Epidemiology and Animal Health](#), and the appropriate commodity program may be required prior to deployment of new test methods to NAHLN laboratories.
