The following is a Freedom of Information Act request, pursuant to 5 U.S.C. § 552:

(1) Produce all documents that relate in any way to Salmonella enteritidis (SE) testing, monitoring, serotyping, phage-typing, and/or pulsed field gel electrophoresis (collectively the "SE Processes") for Keith Smith Company in National Veterinary Services Laboratories (NVSL)'s possession dated from January 1, 2005 through the present, including all results of such SE Processes, and all Keith Smith Company-related laboratory and agency reports, files, written and electronic correspondence among NVSL representatives and between representatives of NVSL, Arkansas Livestock and Poultry Commission and/or Keith Smith Company, and all other Keith Smith Company-related records prepared, received or kept by NVSL concerning such SE Processes.

(2) Produce all SE positive isolates for Keith Smith Company from January 1, 2009 through the present, including but not limited to the isolate from the SE positive sample submitted by ALPC to NVSL in or around December 2009, to Oregon Department of Agriculture, 635 Capitol St NE, Salem, OR 97301-2532, attention: Lee Effinger, Animal Health Laboratory Supervisor.
