


3. All Reports of Salmonella Isolations to NPIP Official State Agencies (VS Form 9-6) from July 2009 through 2010;
4. All Investigations of Salmonella Isolations in Poultry (VS Form 9-7) from July 2009 through July 2010;
5. Any official suspensions or warnings made by NPIP to Featherland Farms regarding health status from July 2009 through July 2010; and
6. All Requests for Salmonella Serotyping (VS Form 10-3) from July 2009 through July 2010.

Please note that I am an attorney representing Keith Smith Company Inc., an egg supplier, who has been sued by Lamont's Featherland Farms and Pacific Pride Chicks, LTD for allegedly supplying eggs contaminated by Salmonella.
