Any and all reports, submitted, filed or documented by Wade Carlson or any other employee of USDA Animal and Plant Health Inspection Service Wildlife Services for services rendered to the Town of Mammoth Lakes, the USDA Forest Service-Mammoth Ranger District, Mono County, Department of Fish and Game or private individuals from May 1, 2009 through October 31, 2009, and more specifically as relates to Agreement Number: 09-73-06-9-346-FA, Account Code: 983-7306-915.
2. Any and all invoices for services rendered under any agreements between USDA Animal and Plant Health Inspection Service Wildlife Services and the Town of Mammoth Lakes, the USDA Forest Service-Mammoth Ranger District, Mono County, Department of Fish and Game or private individual from May 1, 2009 through November 19, 2009.

APHIS employees conducted a search of their files and located the enclosed eight pages responsive to your request. Information has been withheld under FOIA Exemption 6, 5 U.S.C. § 552 (b)(6). This exemption protects information from disclosure when its release would cause a clearly unwarranted invasion of personal privacy.


