

Pursuant to the provisions of the Freedom of Information Act, 5 U.S.C. 552, the undersigned requests the following documents:

1. Description of Records Sought:

- a. All records concerning the recall of Fort Dodge Animal Health's (Wyeth) Rabvac 3 TF vaccine, serial 873113A, which took place on or near May 15, 2006.
- b. All records concerning the investigation, testing, research, and/or study of Fort Dodge Animal Health's (Wyeth) Rabvac 3 TF vaccine, serial 873113A.
- c. All records indicating that Fort Dodge Animal Health's (Wyeth) Rabvac 3 TF vaccine, serial 873113A failed to provide rabies protection for a dog that was administered the vaccine on May 3, 2005, and which contracted the rabies virus in January 2006.
- d. All records indicating that Fort Dodge Animal Health's (Wyeth) Rabvac 3 TF vaccine, serial 873113A failed to provide rabies protection for any other dog or test study to which the vaccine was administered.
