Handling of all animals shall be done as expeditiously and carefully as possible in a manner that does not cause trauma, overheating, excessive cooling, behavioral stress, physical harm, or unnecessary discomfort.

Stanford University failed to ensure the appropriate handling of a non-human primate (NHP) that would prevent trauma, overheating, excessive cooling, behavioral stress, physical harm, or unnecessary discomfort. During a procedure, a heating lamp was used to illuminate the animal's head. Erroneous use of the heating lamp caused a significant thermal injury to the animals face around the left eye and ear and were classified as second degree burns.

You failed to establish and maintain programs of adequate veterinary care that included the use of appropriate methods to prevent, control, diagnose, and treat diseases and injuries at your facility. A red female bloodhound, ID #<sup>(b) (6), (b) (7)(c)</sup>, had a growth on top of her head about one inch in diameter. The growth was hairless and rough with a small amount of dried blood and pink tissue along the base of the back side.

A female Wheaton terrier, ID #<sup>(b) (6), (b) (7)(C)</sup>, had matted hair on her legs, back, and rear end.

**9 C.F.R.** § **3.4(b)(4)** Outdoor housing facilities. (b) Shelters in outdoor facilities for dogs or cats must contain a roof, four sides, and a floor, and must: (4) Contain clean, dry, bedding material if the ambient temperature is below 50 °F (17 °C) or lower.

You failed to ensure the shelters in the outdoor facilities contained clean, dry, bedding material if the ambient temperature is below 50 °F or lower. An outdoor enclosure housing at least 43 dogs contained insufficient bedding. The temperature at the time of the inspection measured 48.5 °F, and according to historical weather data, the low temperature for the last 24 hours in the area was 28 °F.

**9 C.F.R.** § **3.6(a)(2)(iii)** Primary enclosures. (a) General requirements. (2) Primary enclosures must be constructed and maintained so that they: (iii) contain the dogs and cats securely.

You failed to ensure that primary enclosures were constructed and maintained so that they contained dogs securely. A divider fence between two outdoor enclosures had a hole with exposed wire points protruding into it, and APHIS observed a dog using this hole to pass from one enclosure to another.


**9 C.F.R.** § **3.9(a)** Feeding. (a) Dogs and cats must be fed at least once each day, except as otherwise might be required to provide adequate veterinary care. The food must be uncontaminated, wholesome, palatable, and of sufficient quantity and nutritive value to maintain the normal condition and weight of the animal.

You failed to provide dogs with uncontaminated, wholesome, and palatable food. You placed food on the floor of the whelping boxes for puppies in three enclosures of the large breed whelping building. APHIS observed feces mixed with food in at least one of the whelping boxes and witnessed a puppy urinating near the food in another.

#### Date of Alleged Violation: (b) (6), (b) (7)(C) , 2014

**9 C.F.R.** § **3.11(a)** Cleaning, sanitization, housekeeping, and pest control. (a) Cleaning of primary enclosures. Excreta and food waste must be removed from primary enclosures daily, and from under primary enclosures as necessary to prevent an excessive accumulation of feces and food waste, to prevent soiling of the dogs or cats contained in the primary enclosures, and to reduce disease hazards, insects, pests and odors.

You failed to remove excessive accumulation of feces from four enclosures in the elevated outdoor section of the sheltered facility and six outdoor enclosures.

You failed to have a responsible adult available to accompany APHIS officials during an inspection.



You used Cyonara Plus, a fly repellant labeled for use with cattle, on dogs in the facility for fly control. You also had a bottle of liquid neomycin in the large whelping building. There were no directions and approval for use on dogs from a licensed veterinarian for either of these medications.

**9 C.F.R. § 3.1(a)** Structure; construction. Housing facilities for dogs and cats must be designed and constructed so that they are structurally sound. They must be kept in good repair, and they must protect the animals from injury, contain the animals securely, and restrict other animals from entering.





You failed to ensure that housing facilities were designed and constructed so that they were structurally sound and kept in good repair to protect the animals from injury and contain the animals. You failed to keep the following facilities in good repair:

- 1) Outdoor enclosure in the large dog whelping building with a deep hole dug in the ground, resulting in a gap between the fence and the ground.
- 2) Outdoor enclosure housing four dogs on the northwest side of the facility with a deep hole dug in the ground, creating a small cave-like hole.
- 3) Two enclosures housing Australian shepherds with cattle panels attached to chain link fence as a patch. Panels were loose and created a gap between the panel and the fence.



You failed to establish and maintain programs of adequate veterinary care that included the use of appropriate methods to prevent, control, diagnose, and treat diseases and injuries at your facility. An adult female Shih Tzu, with chip # had reportedly been in a fight with another dog. Skin on its right rear leg was red and wet with discharge. You treated the dog with antibiotics, but did not seek veterinarian care.

**9 C.F.R. § 3.1(a)** Structure; construction. Housing facilities for dogs and cats must be designed and constructed so that they are structurally sound. You failed to ensure that housing facilities were designed and constructed so that they were structurally sound and kept in good repair to protect the animals from injury and contain the animals. Two enclosures had sharp wire points that turned inward into the enclosures, and a heating pad in an enclosure in the whelping building had an electrical cord with a protective metal spring casing that was bent and distorted.

(b)(1) Every dealer other than operators of auction sales and brokers to whom animals are consigned, and exhibitor shall make, keep, and maintain records or forms which fully and correctly disclose the following information concerning animals other than dogs and cats, purchased or otherwise acquired, owned, held, leased, or otherwise in his or her possession or under his or her control, or which is transported, sold, euthanized, or otherwise disposed of by that dealer or exhibitor. The records shall include any offspring born of any animal while in his or her possession or under his or her control.

You failed to make, keep and maintain records that fully reflect an accurate count of animals on hand including: 1 pig, 2 sheep, 2 goats, 11 rabbits, 3 Guinea pigs, 1 ferret, 1 calf, 1 llama, and 1 alpaca. The facility was also unable to demonstrate the disposition of animals previously recorded on the inventory including: 1 calf, 2 white tailed deer, 1 red kangaroo, 1 zebra, 1 llama and 1 alpaca.

(c) Storage. Supplies of food and bedding shall be stored in facilities which adequately protect such supplies against deterioration, molding, or contamination by vermin. Refrigeration shall be provided for supplies of perishable food.

You failed to adequately store food to protect against deterioration, molding, or contamination and to maintain wholesomeness. A large amount of produce, used as bear food, was stored on the ground, partially eaten by feral rabbits.

(a) Structural strength. The facility must be constructed of such material and of such strength as appropriate for the animals involved. You failed to construct animal enclosures constructed of such material and of such strength as appropriate for the animals involved. The primary enclosure for a bear cub consists of cattle panels (approximately 4 feet high) tied together. The enclosure includes an electric fence (one strand circling the interior of the enclosure) designed to keep the cub from climbing out of the enclosure, but does not contain a secondary containment measure in the event the hot wire loses access to power.




