

Bring a Pet Dog into the United States

The Centers for Disease Control and Prevention (CDC) is the primary government authority for pet dogs imported into the United States, including returning U.S.-origin dogs.

APHIS Veterinary Services has requirements ONLY if your dog is coming from a foot and mouth disease (FMD) or screwworm-affected country.

Pet Dogs Imported from an FMD-Affected Country

If your pet dog is coming from a country or region where <u>foot and mouth disease</u> is known to exist, you must meet the following requirements:

- Their fur and bedding must be free of excessive dirt, hay, or straw.
- The dog should be bathed as soon as it reaches its destination and kept separate from all livestock for 5 days after entering the United States.

Note: There is no documentation required to meet FMD requirements.

Pet Dogs Imported from a Screwworm-Affected Country

If your pet dog is coming from a country or region where <u>screwworm</u> is known to exist, it may enter the United States only if it is accompanied by a certificate signed by a full-time salaried veterinary official (official government veterinarian) of the region of origin* stating that:

- The dog has been inspected for screwworm within 5 days prior to shipment to the United States; and
- The dog is either free from screwworm OR
- The dog was infested with screwworm, held in quarantine, and treated until free from screwworm prior to leaving the region.

For more information about obtaining certificate endorsement by an official government veterinarian, contact the Animal Health Competent Authority of the country your pet is traveling from. The Animal Health Competent Authority is the Veterinary Authority or other Governmental Authority with responsibility for ensuring implementation of animal health and welfare measures, including enforcement of international veterinary certification standards for the entire country. Note: APHIS Veterinary Services does not have a required template or form for screwworm freedom certification. The certification can be a standalone document or incorporated into an export health certificate issued in the exporting country. Documentation will be reviewed and the dog inspected at the port of entry.

Additional Requirements

Livestock Handling Dogs

Dogs used in livestock handling that are imported from any part of the world except Canada, Mexico, and certain regions of Central America and the West Indies should have no evidence of tapeworm infection.

Dogs for Commercial Resale or Adoption

APHIS <u>Animal Care</u> regulates dogs imported for commercial purposes, such as resale or adoption. <u>View additional requirements for commercial dog imports</u>.
