**The issuing /official veterinarian certifies that all birds covered by this certificate have been inspected and attests to the following statements:**

1. The veterinarian issuing the certificate completed inspection and testing of the birds covered under this health certificate.
2. The bird(s) was/were not vaccinated against any H5 or H7 subtype of avian influenza. If the birds were vaccinated, the date of vaccination and name of vaccine is listed on the health certificate. 30 days quarantine is required for vaccinated animals.

3. The birds were examined by the veterinarian issuing the health certificate within 30 days prior to export, and shows no evidence of communicable diseases of poultry.
4. The bird(s) covered by this certificate do not originate from flocks nor had contact with any birds or poultry originating in a control zone established by state/provincial/federal animal health authorities due to outbreaks of Newcastle disease or Highly Pathogenic Avian Influenza (HPAI) in the 90 days preceding the exportation.
5. CHOOSE EITHER OPTION A OR B BELOW:
  - A. The bird(s) was/were not vaccinated against Newcastle disease  
**OR**
  - B. The bird(s) were vaccinated against Newcastle disease (avian paramyxovirus) at least 21 days prior to export, using vaccines that do not contain any velogenic strains of Newcastle disease virus. **(The health certificate must specify)**
6. The shipment will not transit through any region where APHIS considers highly pathogenic avian influenza to exist.
7. There was no evidence of avian communicable disease (s) found among the birds being shipped
8. The birds were placed in new or appropriately sanitized packaging materials at the premises from which the birds were to be exported.
