Equine Import Requirements for U.S. Returning Horses

This notice provides the required import documentation for U.S. origin mares and stallions returning to the United States after residing in countries which APHIS recognizes as affected with Contagious Equine Metritis (CEM) for a maximum of 60 days in accordance with the Code of Federal Regulations (CFR) <u>93.301(g)</u>. The list of APHIS-recognized CEM countries can be found here: <u>USDA APHIS | Animal Health Status of Regions</u>.

Required Import Documentation

- i. Copy, original, or certified true copy of the U.S. export health certificate.
 - a. Proof of date of arrival in the CEM affected region must be shown by stamp OR other documentation (i.e., trace paper, airway bill, import permit).
- ii. Original U.S. import permit issued prior to the horse(s) leaving the United States.
 - a. Must submit permit application at least 7 business days prior to departure from the United States.
 - b. Permit application should include itinerary. Changes to the issued import permit must be requested and completed prior to return to the United States.
- iii. Original health certificates from each CEM-affected country visited.
 - a. Each health certificate must include the additional CEM attestations as outlined in section VI of the attached supplemental health certificate.
 - i. The attached supplemental health certificate may be issued by each CEM-affected country visited if it is not the final country of residence exporting to the United States.
 - ii. An official health certificate (not the supplemental) must be issued by the final country of residence exporting to the United States.
 - b. Each supplemental health certificate must be endorsed by an official full-time salaried Competent Authority of Animal Health of each issuing country, except that:
 - i. When residing in and moving between EU Member States, each supplemental health certificate may be endorsed by an examining veterinarian (i.e., licensed or FEI official) only.
- iv. If in continuous transit between/in CEM-affected countries:
 - a. If in transit for 24 hours or more, additional transit documentation is required to cover dates not represented on the health certificates, such as:
 - i. Original or certified true copies of intrastate/trace papers including dates of travel from one CEM affected country to the next or,
 - Original travel certification on letterhead from an examining veterinarian (i.e. licensed or FEI official veterinarian) including dates of travel and CEM attestations as outlined in section VI of the attached supplemental health certificate. This is only accepted if the issuing veterinarian travels with horses during the time indicated.
 - b. If in transit for 36 hours or more in any one country, a health certificate in accordance with section iii. is required.

v. The health certificates must collectively represent the entire time from the date of export from the United States until the horse(s) return(s).

vi. All required documentation must be presented at the port of entry.

If required documentation is not presented at time of arrival or if U.S. horses have resided more than 60 days in a CEM affected region prior to return, CEM testing and quarantine will be required at a state approved facility. USDA encourages importers to verify that all U.S. import requirements are met prior to export.

Supplemental Health Certificate for the Temporary Export of U.S. Origin Horses from the United States to multiple CEM-Affected Regions in the 60 days Preceding Return to the United States and Requiring a Three-Day Quarantine

I, the undersigned, certify that the horse described above meets the following requirements:

- a. The horse has been residing in the country specified above for _____ (number) days.
- b. The horse described was inspected on the premises listed above on _____(mm/dd/yyyy) and found to be free of contagious diseases and, insofar as can be determined, not exposed to communicable or contagious diseases immediately preceding exportation, during the indicated period of residency;
- c. The horse has not been vaccinated with a live, attenuated or inactivated vaccine during the period of residency if within 14 days preceding exportation to the United States.
- d. That, insofar as I can determine, African horse sickness, dourine, glanders, surra, epizootic lymphangitis, ulcerative lymphangitis, equine piroplasmosis, equine infectious anemia (EIA), contagious equine metritis (CEM), vesicular stomatitis, or Venezuelan equine encephalomyelitis has not occurred on the residing premises during the period of residency, nor have these diseases occurred on any adjoining premises during the same period of time;
- e. The horse was examined and found to be free of ectoparasites.

VI. Contagious Equine Metritis (CEM) attestations for intact mares and stallions:

- a. Insofar as I can determine, since residing in _____(temporary country of residence), the horse:
 - has been held separate and apart from all other horses except for the time it was actually participating in an event or was being exercised by its trainer;
 - has not been on any premises where horses were held or used for breeding purposes;
 - has not been bred nor had other sexual contact or genital examination while residing in the above country;
 - has been transported only in cleaned and disinfected vehicles and was not accompanied by any other horse of a different health status.
