5. I / WE AGREE TO THE FOLLOWING:

- 1) That I will review all import requirements and transit safeguards for overland movement as listed in the "FAVIR" website at <http://www.aphis.usda.gov/favir/> for the importation and transit of the untreated mangoes from Pakistan.
- 2) That I will ensure that any person who brings into, unloads, maintains, transfers, transports or otherwise possesses or moves the regulated articles into and through the United States on my behalf are made aware of all applicable import requirements and transit safeguards for overland movement as listed in the "FAVIR" website.
- 3) That I will obtain an Import Permit, signed by the Animal and Plant Health Inspection Service, Plant Protection and Quarantine, prior to the importation of any shipments of regulated articles.
- 4) That I will abide by all conditions and safeguards provided in this Compliance Agreement and the associated Import Permit issued by Animal and Plant Health Inspection Service, Plant Protection and Quarantine.
- 5) That I will abide by any amendments to this Compliance Agreement or associated Import Permit. All amendments will be made available to me in the "FAVIR" website, and will also be provided to me in a new issuance of my Import Permit.
- 6) If I, or other custodians of the regulated articles who are operating on my behalf, fail to abide by this Compliance Agreement or the associated Import Permit, I acknowledge that I may be subject to civil or criminal penalties, and/or the cancellation of the Compliance Agreement and associated Import Permit, which will result in the refusal at the Port of Entry of all subsequent importations of regulated articles.
- 7) That I, or my agents, will be responsible for all costs associated with the transportation and/or safeguarding of the regulated articles.
