## **CONDITIONS GOVERNING THE IMPORTATION OF TROPICAL AQUARIUM FISH & OTHER AQUATIC SPECIES INTO THE CAYMAN ISLANDS**

Prior to applying for an import permit, prospective importers must first apply to the **Department of Environment** for permission to import live aquarium fish and other aquatic animal species.

All fish, fingerlings, fry gametes, eggs and other aquatic animal species entering the Cayman Islands **must** be accompanied by an Import Permit issued by the Cayman Islands Department of Agriculture and a completed **Official International Aquatic Health Certificate** issued within 14 days of arrival in the Cayman Islands.

The Official Aquatic Health Certificate must be endorsed by a full-time salaried Veterinary Officer of the National Government of the country from which the fish are to be exported, and must contain:

1. The common and scientific names of the species to be imported
2. The type of stock being imported (cultured, wild, fish, fry, gametes)
3. Origin of consignment
4. Number of fish or total weight of consignment
5. Name and address of consignor
6. Name and address of consignee
7. Health declaration:
  - a. The stock to be exported have been examined and as best as can be ascertained show no signs of infectious disease, parasitism or pathology
  - b. The animals in the shipment are not currently displaying clinical signs, or undergoing treatment for a case of disease caused by *Streptococcus iniae*, *Aeromonas hydrophilia* (*Furunculosis*), *Flexibacter columnaris* (*Columnaris disease*), *Trichodina spp.* or Iridovirus. The aquaculture establishment of origin regularly monitors for clinical signs of disease caused by these agents.

The application fee in the amount of CI\$50 (US\$61) per consignment may be in the form of CI cash, cheque drawn on a local Cayman Islands bank, international money order or a cashier's cheque drawn from a US bank payable to the **Cayman Islands Government**.
