**Notice Regarding Pet Supplements Exported to Canada:** 

As of June 24, 2024, Thermally Processed pet supplements can be exported to Canada using the Veterinary Export Certificate for Thermally Processed Pet Food Products Containing Animal-Origin Ingredients Exported from the United States of America to Canada (249 KB).

The facility manufacturing the pet supplements must be under APHIS inspection, if the facility has a current APHIS facility number and has been inspected for thermally processed pet food products (pet food, pet treats, compound chews), no additional action is needed. If the facility producing the pet supplements is not currently under APHIS inspection for export to Canada, then the facility should contact their <a href="VS Field Office">VS Field Office</a> covering the area in which the product is manufactured to obtain pre-inspection documents and schedule an inspection.
