# Export Live Animals to Japan

## Electronic Signature ACCEPTED; Digital Endorsement for SOME COMMODITIES ONLY

**For Accredited Veterinarians:** Electronic signature ACCEPTED

**For APHIS VMO:** Digital endorsement for SOME COMMODITIES ONLY

USDA-accredited veterinarians can electronically issue health certificates and use VEHCS (Veterinary Export Health Certification System) to submit them to USDA for endorsement.

**Digital endorsement varies by species—see requirements on this page for details.** The health certificate either bears the original ink signature and embossed seal **or** digital signature/seal.

What This Means for You

**Animal Owners/Shippers:** Digitally endorsed health certificates can be printed out directly from VEHCS. For non-digitally endorsed health certificates, you can arrange

to have your health certificate returned by mail (a prepaid, preaddressed return label must be provided during certificate submission). A paper version of the endorsed health certificate must accompany the animal(s) during shipment or travel.

## Summary of Requirements

For all commodities other than the animal commodities listed\* below to Japan, USDA Accredited Veterinarians may issue health certificates electronically through the online Veterinary Export Health Certification System ([VEHCS](#)). These certificates will be digitally endorsed by APHIS once received in the system and available for printing by the USDA Accredited Veterinarian once the endorsement is completed by APHIS. An APHIS-endorsed, printed paper copy **must** accompany the shipment.

Health certificates for the animal commodities listed\* below, may be submitted by the USDA Accredited Veterinarian through [VEHCS](#); however, the APHIS Veterinary Medical Officer's ink (wet) signature with the application of the APHIS embossed seal must appear on the health certificate. Certificates received by APHIS through the VEHCS system will be printed and endorsed in our offices, and the hard copy will be returned when complete. This APHIS-endorsed and embossed paper copy **must** accompany the shipment.

## Swine

**Note:** The following certification statements must appear on health certificate for swine and swine semen to Japan:

*"There has been no clinical evidence of PED on the premises of origin of the live swine animals for export for at least 12 months prior to the start of export isolation."*

*Test requirements during export isolation: "PED: PCR test using fresh feces with negative result"*

If your species is not listed, the requirements for that species are not known. Exporters who want to ship livestock or germplasm whose requirements are not listed above should have the importer or buyer in the destination country apply for an import permit at the appropriate ministry. This import permit will most likely outline the specific requirements.

## **Tips for Exporters and Accredited Veterinarians**

### **Endorsement Services**

- **No in-person or drop-off services.**
- For fastest processing, have your [accredited veterinarian](#) **submit certificates through [VEHCS](#).**
- Routine APHIS VEHCS processing services are staffed Monday through Friday from 7:00 a.m. to 4:30 p.m. Central Time (CT), excluding Federal holidays. The time listed in VEHCS reflects GMT.
- Paper certificates are discouraged but may be mailed to one of our two paper endorsement offices (see addresses below).

### **Status Updates**

Endorsement offices **cannot confirm delivery or provide status updates.** For updates:

- Contact your [accredited veterinarian](#) (they can check VEHCS status).
- Use your **mail tracking number.**

## **Important Tips**

- Ensure accuracy and submit documents as early as possible within the allowed timeline of the destination country to avoid delays.
- Use **overnight or Saturday delivery** when mailing.
