Samantha (Sam) Simon has joined the Office of the Deputy Administrator as the Associate Deputy Administrator for PPQ, and Calvin Shuler has been selected as the Executive Director for Field Operations.

He started working as a Canine Officer in 1993 based in Charlotte, NC, and eventually became the Regional Canine Coordinator in 1995. Two years later, he became a Regional Program Manager based in Gulfport, MS, and then the Senior Regional Program Manager for Risk Management, including Agricultural Quarantine Inspection in 2003. Since 2015, Calvin has served as Associate Executive Director based in Raleigh, NC, for District 5, Pest Detection, Farm Bill/PPA 7721, and Emergency Management. Additionally, Calvin acted as the Executive Director for Field Operations (FO) from January 2021 to August 2021.

While Calvin's career has been focused on FO, he has served in other parts of PPQ in various acting roles, such as National Canine Program Manager of the National Detector Dog Training Center, and Director of Quarantine, Policy, Analysis, and Support. From March 2020 to December 2020, he served as PPQ COVID-19 Incident Commander.

Calvin and his wife, Rhonda, live outside of Raleigh. They enjoy spending time with their new granddaughter, Avery, and their son Taylor and his wife, Natalie. Calvin and his family enjoy fishing and camping.
