Travel Requirements Based on Pet Type

- This page provides the most recent entry requirements and can change without notice.
- It is the responsibility of the veterinarian to make sure the pet has met all health requirements of the destination country before issuing a health certificate.
- Failure to meet the requirements may result in problems gaining certificate endorsement or difficulties upon arrival in the destination country.
- Health certificates must be legible, accurate, and complete.

The information, requirements, and websites posted below are the most current known to APHIS.

An <u>import permit</u> is required send a pet to the British Virgin Islands. The <u>import permit</u> will outline the specific requirements your pet must meet to travel to the British Virgin Islands. An APHIS-endorsed health certificate IS required PRIOR to applying for an import permit. A rabies titer IS REQUIRED for the import permit

application. These requirements (e.g., vaccinations, tests, and treatments) must be recorded on the export health certificate

Agricultural Officers will conduct animal quarantine duties for the <u>British Virgin</u>
<u>Islands Department of Agriculture</u>, which has an office at the Terrance B. Lettsome
Airport. For pets arriving by sea, the Department requires 24 hour notice of arrival to
ensure that appropriate arrangements can be made for inspection of relevant
papers.

Important Travel Considerations

Considerations for airline travel and cruises:

^{*} Northern Ireland is part of the United Kingdom (UK), but will continue to follow European Union (EU) requirements even though the UK is no longer part of the EU.

^{**} Norway and Switzerland are **not** part of the EU but have adopted EU legislation for import of most species of live animals.



Airlines and shipping lines have their own policies and requirements for transporting pets. Check with your airline or shipping representative to determine what requirements they may have.

View APHIS Requirements

ALERT: If you're traveling with a dog, be aware that the <u>CDC has additional</u> requirements for bringing a dog into the <u>United States</u>. You must follow CDC's requirements, or your dog will not be allowed to enter the <u>United States</u>.

If you are transiting (passing through) the European Union:



If your pet is traveling through (transiting) a country in the European Union (EU) on the way to a third, non-EU country, you will also need a transit health certificate for your pet for the EU. The transit health certificate will be the same as if your pet's final destination was the EU country. Use the information and steps above under "Travel Requirements Based on Pet Type" to determine which health certificate should be used. View a list of EU countries.
