1. The pet birds were hatched and raised or have been, for at least 30 days prior to the exportation, in the United States.
2. The United States is officially free from high pathogenic avian influenza (HPAI) in accordance with the OIE and Korea's import health requirements for birds other than poultry.
3. The pet birds have been isolated in quarantine facilities approved by the USDA for at least 21 days prior to shipment and inspected by a USDA-accredited veterinarian and were found to be free of any evidence of infectious poultry diseases.
4. The pet birds are being transported in new, cleaned, and disinfected (with a disinfectant acceptable to APHIS) containers.
5. I have checked the IREGS and read in its entirety the protocol for Import Health Requirements for Birds other than Poultry to the Republic of Korea and understand all associated additional requirements, if applicable, have been followed accordingly.
