

**HEALTH REQUIREMENTS FOR THE IMPORTATION OF
BREEDING DAY OLD CHICKEN (DOC) OR POULTRY HATCHING EGGS
FROM USA INTO INDONESIA**

(Empowered law No. 16, 1992, Law No. 18, 2009 juncto No.41, 2014, Government Regulations No. 47, 2014, Government Regulations No. 82, 2000)

I. CERTIFICATE OF HEALTH

The importation of breeding DOC or poultry hatching eggs should be accompanied by a sanitary health certificate from country of origin, issued by an Authorized Veterinarian of the country of origin certifying that:

1. The chicken hatching eggs or breeding Day-old chicks (DOC) originate from
EITHER* (i) The United State of America (USA)
OR* (ii) A region (county) of the USA
OR* (iii) A poultry compartment within the USA
which is officially free from notifiable avian influenza (NAI) according to the criteria of the OIE Code
In the event of NAI outbreak in the USA, an AI freedom statement must be included on the health certificate.
2. The breeding DOC or poultry hatching eggs come from establishments/farm where within a radius of six (6) kilometres there have been no know outbreaks nor have there been any reports of low pathogenic avian influenza during the last 6 (six) months before shipments.
3. The flock(s) of poultry is in a farm in which the eggs produced are officially free from *Salmonella pullorum*, *Salmonella gallinarum*, *Salmonella enteritidis*, and *Salmonella thyphimurium* and they were subjected to official test for Salmonella with negative results. Those test should be done at a government approved laboratory and the date of test with negative results shall be stated in the certificate of health.
4. The flock (s) of poultry were kept in establishment/farms in which no case or outbreak of avian tuberculosis, ornithosis, infectious stunting syndrome, chicken anemia agent, infectious bronchitis (IB), infectious laringotracheitis (ILT), fowl cholera, fowl typhoid, listeriosis, botulism, clostridium infections, egg drop syndrome, infectious bursal disease (IBD), Marek's disease, mycoplasmosis, avian encephalomyelitis was reported within 6 (six) months prior to shipment.
5. The poultry farms where the eggs were produced and/or held must be under routine inspection by the USDA accredited Veterinarian and no evidence of clinical symptom of all infectious diseases within 21 days preceding the inspection.
6. The flock(s) of poultry were kept in establishments in which routine vaccination program against infectious bursal disease (IBD), Marek's disease, infectious bronchitis (IB), fowl cholera and other vaccination programs are practiced on the great grandparent stock/grandparent stock/parent stock (nature of vaccine used and the dates of vaccination shall also be stated in the certificate).
7. The breeding DOC could be vaccinated against coccidiosis either at day one or 3 using coarse spray on the day of ages days
8. Disinfection or fumigation of poultry hatching eggs should be carried out prior to packages with hygiene and disease security procedure.
9. The breeding DOC or poultry hatching eggs will be inspected by a USDA accredited veterinarian within 48 of export and the DOC showed no clinical signs of communicable disease.

II. OTHER CONDITION

1. The breeding DOC or poultry hatching eggs are shipped in clean or new packages.

2. Any poultry hatching eggs showing evidence of any visible break in boxes/containers/packages shall be taken out from the consignment and reject to be loaded.
3. The original certificate of health must be handed over to the captain, and a copy to the Indonesia Representative in the country of origin.

III. **TRANSPORTATION**

The ship/plane which will be used for carrying those poultry hatching eggs/DOC shall be in clean condition.

IV. **QUARANTINE MEASURES IN INDONESIA**

On arrival at the port of destination, all consignments of breeding DOC must comply with the prevailed regulation of animal quarantine
