

IMPORT HEALTH REQUIREMENTS OF THE STATE OF SARAWAK, MALAYSIA FOR IMPORTATION OF LIVE BREEDING PIGS FROM THE UNITED STATES.

1. This license is issued subjected to the consignment of livestock mentioned above accompanied by a valid certificate from a Government Veterinary Authority from the country of origin that the livestock exported are free from diseases of an infectious or contagious nature.
2. At the time of importation this permit together with the Veterinary Health Certificate should be produced for inspection. Failure to produce these documents will result in permission being refused to land the animals.
3. Veterinary Certification
 - 3.1. The country must be certified free from
 - 3.1.1. Swine Fever,
 - 3.1.2. Rinderpest
 - 3.1.3. African Swine Fever
 - 3.1.4. Foot and Mouth Disease
 - 3.2. Animals must be derived from farms clinically free from
 - 3.2.1. Atrophic rhinitis,
 - 3.2.2. Transmissible Gastroenteritis (TGE),
 - 3.2.3. Aujeszky's Disease
 - 3.2.4. Swine Vesicular Disease
 - 3.2.5. Vesicular Stomatitis
 - 3.2.6. Teschen Disease (Polioencephalomyelitis)
 - 3.2.7. Swine Influenza
 - 3.2.8. Brucellosis suis
 - 3.2.9. Rabies
 - 3.2.10. Post Weaning Multisystemic Wasting Syndrome (PMWS)
 - 3.2.11. Swine Parvovirus
 - 3.2.12. Porcine Dermatitis and Nephropathy Syndrome (PDNS)
 - 3.3. Within 30 days of export, the animals must be submitted to the following tests with negative result.
 - 3.3.1. Brucellosis (*Brucella suis*) (CFT or SAT);
 - 3.3.2. Leptospirosis (MAT) of less than 1/100 or farm certified free of leptospirosis serotype Pomona, tarassovi (hypos), canicola and icterohaemorrhagic; (Not required if Certification Statement Number 3.3.4 can be made)
 - 3.3.3. Blue Eared Pig Disease (PRRS) (ELISA or IFA at 1:20)
 - 3.3.4. The animals have been treated with dihydrostreptomycin at a dose rate of 25mg/kg bodyweight within seven days of export or treated twice with long-acting oxytetracycline at a rate of 20 mg/kg at an interval of 14 days with the last treatment seven days before the export.

- 3.4. A health certificate signed by a Government Veterinary Officer certifying that he has examined the animals prior to export and found them to be healthy and free from any clinical symptom of infectious or contagious diseases at the time of export
4. The animals must be identified with permanent identification using tattoo or ear-tagged
5. Animals should be carried by ship/aircraft or sealed trucks direct to the prescribed landing place or port and may subject to transshipment as directed by State Veterinary Authority, Sarawak
