Pet Food

Processed pet food other than canned:

Bosnia and Herzegovina require bilingual "HEALTH CERTIFICATE For processed petfood other than canned petfood, intended for import into or for transit through Bosnia and Herzegovina (BiH)" for the import of processed pet food (other than canned pet food).

This certificate mimics the requirements of the Regulation (EC) 142/2011 (as amended) "Chapter 3(B) HEALTH CERTIFICATE For processed petfood other than canned petfood, intended for dispatch to or for transit through the European Union." Prior to endorsement of the "HEALTH CERTIFICATE For processed petfood other than canned petfood, intended for import into or for transit through Bosnia and Herzegovina (BiH)" the pertinent exporting/processing facilities must be approved by APHIS Veterinary Services for endorsement of the Regulation (EC) 142/2011 (as amended) "Chapter 3(B) HEALTH CERTIFICATE For processed petfood other than canned petfood, intended for dispatch to or for transit through the European Union." For information on how to receive this required approval, a facility should contact the Veterinary Services service center covering the area where the facility is located.

Canned pet food:

Bosnia and Herzegovina require bilingual "Health certificate Za konzerviranu hranu za kućne ljubimce za uvoz u Bosnu i Hercegovinu (BiH) ili provoz kroz nju / For canned petfood intended for import into or for transit through Bosnia and Herzegovina (BiH)" for the import of canned pet food.

This certificate mimics the requirements of the Regulation (EC) 142/2011 (as amended) "Chapter 3(A) Health certificate For canned petfood intended for dispatch to or for transit through2 the European Union." Prior to endorsement of the "Health certificate Za konzerviranu hranu za kućne ljubimce za uvoz u Bosnu i Hercegovinu (BiH) ili provoz kroz nju / For canned petfood intended for import into or for transit through Bosnia and Herzegovina (BiH)" the pertinent exporting/processing facilities must be approved by APHIS Veterinary Services for endorsement of the Regulation (EC) 142/2011 (as amended) "Chapter 3(A) Health certificate For canned petfood intended for dispatch to or for transit through2 the European Union." For information on how to receive this required approval, a facility should contact the Veterinary Services service center covering the area where the facility is located.

Dog chews:

Bosnia and Herzegovina require bilingual "Health certificate Za žvakalice za pse za uvoz u Bosnu i Hercegovinu (BiH) ili provoz kroz nju / For dogchews intended for import into or for transit through Bosnia and Herzegovina (BiH)" for the import of dog chews.

This certificate mimics the requirements of the Regulation (EC) 142/2011 (as amended) "Chapter 3(C) Health certificate For dogchews intended for dispatch to or for transit through the European Union." Prior to endorsement of the "Health certificate Za žvakalice za pse za uvoz u Bosnu i Hercegovinu (BiH) ili provoz kroz nju / For dogchews intended for import into or for transit through Bosnia and Herzegovina (BiH)" the pertinent exporting/processing facilities must be approved by APHIS Veterinary Services for endorsement of the Regulation (EC) 142/2011 (as amended) "Chapter 3(C) Health certificate For dogchews intended for dispatch to or for transit through the European Union."
