I, the undersigned full time salaried veterinarian of the United States Department of Agriculture, hereby certify the following: *(check all applicable boxes)*

The shipment includes pet foods with bovine ingredients and these products were produced with:

The meats and meat byproducts used in the certified raw pet food diets were obtained only from carcasses or parts of carcasses subjected to ante and post-mortem inspection.

The raw pet food diets have been packaged in a manner intended to prevent contamination and/or leakage of the products.
