Part II: Certification	<p>I, the undersigned official veterinarian, declare that I have read and understood Regulation (EC) No 1069/2009 of the European Parliament and of the Council, and in particular Article 10 of that Regulation, and Commission Regulation (EU) No 142/2011, and in particular Chapter II of Annex XIII and Chapter II of Annex XIV thereto, and certify that the dogchews described above:</p> <p>II.1. have been prepared exclusively with the following animal by-products:</p> <p>(1) <i>either</i> [- carcasses and parts of animals slaughtered or, in the case of game, bodies or parts of animals killed, and which are fit for human consumption in accordance with retained EU law, but are not intended for human consumption for commercial reasons;</p> <p>(1) <i>and/or</i> [- carcasses and the following parts originating either from animals that have been slaughtered in a slaughterhouse and were considered fit for slaughter for human consumption following an ante-mortem inspection or bodies and the following parts of animals from game killed for human consumption in accordance with retained EU law:</p> <p style="margin-left: 40px;">(i) carcasses or bodies and parts of animals which are rejected as unfit for human consumption in accordance with retained EU law, but which did not show any signs of disease communicable to humans or animals;</p> <p style="margin-left: 40px;">(ii) heads of poultry;</p> <p style="margin-left: 40px;">(iii) hides and skins, including trimmings and splitting thereof, horns and feet, including the phalanges and the carpus and metacarpus bones, tarsus and metatarsus bones;</p> <p style="margin-left: 40px;">(iv) pig bristles;</p> <p style="margin-left: 40px;">(v) feathers;</p> <p>(1) <i>and/or</i> [- blood of animals which did not show any signs of disease communicable through blood to humans or animals, obtained from animals that have been slaughtered in a slaughterhouse after having been considered fit for slaughter for human consumption following an ante-mortem inspection in accordance with retained EU law;</p> <p>(1) <i>and/or</i> [- animal by-products arising from the production of products intended for human consumption, including degreased bone, greaves and centrifuge or separator sludge from milk processing;</p> <p>(1) <i>and/or</i> [- aquatic animals, and parts of such animals, except sea mammals, which did not show any signs of disease communicable to humans or animals;</p> <p>(1) <i>and/or</i> [- animal by-products from aquatic animals originating from plants or establishments manufacturing products for human consumption;</p> <p>(1) <i>and/or</i> [- material from animals which have been treated with certain substances which are prohibited by Council Directive 96/22/EC, the import of the material being permitted in accordance with Article 35(a)(ii) of Regulation (EC) No 1069/2009;</p> <p>II.2. have been subjected</p> <p>(1) <i>either</i> [in the case of dogchews made from hides and skins of ungulates or from fish, to a treatment sufficient to destroy pathogenic organisms (including salmonella); and the dogchews are dry;</p> <p>(1) <i>and/or</i> [in the case of dogchews made from animal by-products other than hides and skins of ungulates or from fish, to a heat treatment of at least 90°C throughout their substance;</p> <p>II.3. were examined by random sampling of at least five samples from each processed batch taken during or after storage at the processing plant and complies with the following standards⁽²⁾:</p> <p>Salmonella: absence in 25g: n = 5, c = 0, m = 0, M = 0</p> <p>Enterobacteriaceae: n = 5, c = 2, m = 10, M = 300 in 1 gramme;</p> <p>II.4. have undergone all precautions to avoid contamination with pathogenic agents after treatment;</p> <p>II.5. were packed in new packaging;</p> <p>(1)II.6. the dogchews described above</p> <p>(1) <i>either</i> [is derived from other ruminants than bovine, ovine or caprine animals;</p> <p>(1) <i>or</i> [is derived from bovine, ovine or caprine animals and does not contain and is not derived from:</p> <p style="margin-left: 40px;">(1) <i>either</i> [bovine, ovine and caprine materials other than those derived from animals born, continuously reared and slaughtered in a country or region classified as posing a negligible BSE risk in accordance with Decision 2007/453/EC;</p> <p style="margin-left: 40px;">(1) <i>or</i> [(a) specified risk material as defined in point 1 of Annex V to Regulation (EC) No 999/2001 of the European Parliament and of the Council;</p> <p style="margin-left: 80px;">(b) mechanically separated meat obtained from bones of bovine, ovine or caprine animals, except from those animals that were born, continuously reared and slaughtered in a country or region classified as posing a negligible BSE risk in accordance with Commission Decision 2007/453/EC, in which there has been no indigenous BSE case,</p> <p style="margin-left: 80px;">(c) animal by-product or derived product obtained from bovine, ovine or caprine animals which have been killed, after stunning, by laceration of the central nervous tissue by means of an elongated rod-shaped instrument introduced into the cranial cavity, or by means of gas injected into the cranial cavity, except for those animals that were born, continuously reared and slaughtered in a country or region classified as posing a negligible BSE risk in accordance with Decision 2007/453/EC.]]]</p>
