

Pet Treats and Similar Products Not Containing Animal Product Ingredients  
for Export to Mexico

The export to Mexico of products intended for animal feeding but that do not contain animal product ingredients require a certificate issued by APHIS Veterinary Services. This is the case for pet treats.

A letterhead certificate may be requested and should be formatted as the model certificate below. The certification statements below are required on the letterhead certificate issued by the Area office. A notarized affidavit from the manufacturer is required to support the statements on the certificate issued by APHIS Veterinary Services.

Required certification statements:
