Endorsing Facility Questionnaires for Mexico

Mexico Rendering or Blending Facility Questionnaires

As a part of the export process for products from rendering plants (as defined by Mexico), Mexico requires the completion of a facility questionnaire (please see attached). Note that this questionnaire was created for use in multiple countries and therefore has options that may not pertain to the U.S.

Our VS Area Offices will receive requests from exporting facilities to approve the questionnaire. Please follow these instructions to complete the process.

Inspection

- 1. The questionnaire should be completed legibly by the responsible plant official before you are asked to approve it. A fillable Adobe form is now also available for APHIS use if you prefer.
- 2. Review the questionnaire to ensure that the facility does not process any ruminant protein, and that the answers to questions 1-7 are "yes". Otherwise, the plant cannot be approved.
- 3. Inspect the facility to verify the accuracy and completeness of the information provided in the questionnaire.
- 4. If the information provided is accurate and complete, sign and date the questionnaire (legibly). Include the address and phone number of the VS Area Office providing this service.
- 5. Give/send the original questionnaire to the exporter and keep a file copy for the VS Area Office. Scan and email a copy to the NCIE's Exports Products mailbox.
- 6. NCIE will assign the facility an approval number if they don't already have one and enter the approval information in the FAEAP database. The number will be the same format as used for the EU and other countries.
- 7. NCIE will review and advise Mexico of the recommendation for approval. Generally Mexico can approve and add the facility to their data base (currently available on http://web2.senasica.gob.mx:8081/PlantaAcreditada/) within a week after we notify them. You should advise facility management that after you have sent the questionnaire to NCIE, it can take up to three more weeks for it to be added to the Mexican list of approved facilities.

User Fees

1. Charge the hourly rate for inspecting the facility and endorsing the questionnaire. Be sure to include the time needed to endorse the questionnaire. The regulatory

authority for issuing a health certificate in conjunction with an inspection is found in 9CFR 130.20c. NOTE: For situations where you cannot charge for the inspection because a facility was charged a flat user fee for an inspection within the last 12 months, charge a user fee for endorsing the questionnaire as described in #2 below.

- 2. Charge the same user fee for endorsing additional questionnaires as is charged for endorsing a VS Form 16-4 (where inspection of the facility is not needed).

After the facility has been approved by Mexico, export certificates may be signed. Requirements should be available on the IREGS, but they are subject to change without notice!
