In the event of an official report by the United States of an incident of notifiable avian influenza, Argentina's SENASA may impose restrictions for the importation of fresh and fresh frozen poultry products.

the following restrictions apply to the following commodities:

For [Thermoprocessed inedible egg derivatives](#), poultry from any area under Federal quarantine for HPAI is ineligible for export to Argentina unless processed to ensure destruction of High Pathogenicity Avian Influenza Virus. Please inquire with the pertinent Service Center to determine the quarantine zones and dates of ineligibility.

For [Thermoprocessed poultry products and by-products](#), poultry from the entire United States is ineligible for export to Argentina effective February 8, 2022.

For [Poultry Cartilage for Pharmaceutical Industry](#): Frozen Poultry Cartilage, poultry from the entire United States is ineligible for export to Argentina effective February 8, 2022.

For [Poultry Cartilage for Pharmaceutical Industry](#): Heat Processed Poultry Cartilage and/or poultry Cartilage Extracts are eligible to export as long as they meet requirements in the health certificate.

Even though Argentina may not have imposed restrictions, APHIS endorsing officials should review the restrictions and verify the relevant AI attestations prior to endorsing certificates under these protocols.

Velogenic Newcastle Disease (vND):

In the event of an official report by the United States of an incident of Newcastle disease, Argentina's SENASA may impose restrictions for the importation of fresh and fresh frozen poultry products that have not been heat treated, notably frozen poultry cartilage.

No vND restrictions are currently in existence for the following products:

Thermoprocessed poultry products and by-products

Rabbit products:

Argentina SENASA advised on April 26, 2010, that animal products from rabbits are restricted unless they have received an appropriate treatment to inactivate rabbit hemorrhagic disease virus.
