Certification Statements :

1. I have verified the presence of the microchip(s) listed in box 21.
2. I certify that the animal(s) described in box 21 have been inspected by me on this date, within 2 (two) weeks of import into Aruba, and appear to be free of any infectious or contagious diseases and, to the best of my knowledge, exposure thereto, which would endanger the animal or other animals or would endanger public health.
3. To my knowledge, the animal(s) described in box 21 originated from an area not quarantined for rabies and has/have not been exposed to rabies.
4. The animals listed in box 21 above (chose one):

Have resided continuously in the USA or Aruba for 6 months, immediately preceding the date of export to Aruba

OR

Were born and have lived in the USA continuously if younger than 6 months of age at the date of export to Aruba

OR

Have written exemption from the above by the Head of the Veterinary Service of Aruba

5. The animals listed in box 21 above have a microchip inserted for unique identification of the pet (AVID or ISO-compatible microchips are required**).
6. Rabies vaccination requirements- Either:

The animals listed in box 21 above are younger than 3 (three) months of age and too young for rabies vaccination

OR

The animals listed in box 21 above have been vaccinated for rabies, as noted below, at least 1 month prior to import into Aruba and the period of validity for the vaccination has not elapsed. *(note: animals receiving booster (non-initial) rabies vaccinations may travel to Aruba without the 1 month waiting period, as long as the previous rabies vaccination is not expired at the time of booster.)*

7. The animal has been inspected by an accredited veterinarian and has been found to be free of fresh or healing wounds, and clinical signs of screwworm.
8. The animals originate from a zone which is not under control for screwworm, and have not transited a zone under control for screwworm within the last 60 days.
