## Important Information Regarding Known Trade Bans on Various Products

## I. Avian Influenza Bans

Prohibition on the export to Belarus of raw poultry-derived pet food ingredients intended for the manufacture of pet food, down and feathers of poultry, avian game trophies, livestock feed/feed ingredients derived from poultry, or livestock feed/feed ingredients of plant origin (unless heat-treated, intended for the production of animal feed, and Belarus issues a permit) originating from:

• the entire United States that are shipped on or after May 9, 2022.

Prohibition on the export to or transit of Belarus of raw poultry-derived pet food ingredients intended for the manufacture of pet food, down and feathers of poultry, technical gelatin derived from poultry, and avian game trophies originating from the State of

Prohibition on the export to or transit of Belarus of livestock feed/feed ingredients derived from poultry or livestock feed/feed ingredients of plant origin (unless heat-treated and issued a permit by Belarus), which left the State of:

- Indiana on or after March 3, 2022;
- Iowa on or after March 29, 2022;
- Kansas on or after March 29, 2022;
- Kentucky on or after March 3, 2022;
- Maine on or after April 12, 2022;
- Maryland on or after March 29, 2022;
- Minnesota on or after April 12, 2022;
- Missouri on or after March 29, 2022;
- Nebraska on or after April 12, 2022;
- New York on or after April 12, 2022;
- South Dakota on or after March 29, 2022;
- Wisconsin on or after March 29, 2022.
