I, the undersigned USDA Accredited Veterinarian, certify to the following statements:

1. The flock of origin of the hatching eggs for export are either U.S. origin or have been in the United States for at least three months, and during this time have not had any contact with imported birds or poultry.

2. Highly pathogenic avian influenza (HPAI) and Newcastle Disease (ND) have not occurred on any premises within a radius of 25 km of the premises of origin for a period of 28 days immediately prior to collection of eggs for export.

3. The flock of origin of the hatching eggs for export has been under the supervision of the USDA accredited veterinarian, and is not under any veterinary restrictions for any diseases which can be transmitted through the eggs.

4. During the 30 days prior to the collection of the hatching eggs for export, the birds in the flock of origin were inspected and found to be free from clinical signs of infectious diseases including: Newcastle disease, fowl plague (avian influenza), infectious avian encephalomyelitis, avian infectious bronchitis, infectious laryngotracheitis, infectious bursal disease, avian reticuloendotheliosis, ornithosis, fowl pox, mycoplasmosis, vibronic hepatitis, salmonellosis, big liver spleen disease (BLS), tuberculosis, acute fowl cholera, and avian leucosis; and none of these diseases have existed within the flock of origin during the preceding six months.

5. The flock has not been vaccinated for avian influenza (AI), and no live Newcastle disease (ND) vaccine or any other live vaccines have been administered during the three months before collection of the eggs for export.

6. All flocks from which the eggs for export were obtained are certified free of Salmonella pullorum.


7. After collection, only clean eggs will be selected, and eggs will then be:

[O] fumigated using formaldehyde gas generated by adding 35 cc of commercial formalin (40% solution) to 17.5 grams of potassium permanganate for each 2.38 cubic meters of fumigation space.

[O] sprayed with or immersed in an eggshell disinfectant, in accordance with the manufacturer's instructions.

[O] subjected to a disinfection procedure approved by the USDA.

NOTE: The hatching eggs will be loaded into clean and disinfected crates, and closed with temper-evident seals, applied under the supervision of the USDA accredited veterinarian. The consignment of eggs must be clearly identified and linked to the
