Not more than one member of a family may import birds under these requirements during any 90-day period. The Canadian Declaration Form (AGR 1553) is available from Canadian Customs at the port of entry. NOTE: For import purposes, the term pet bird means a personally owned and cared for bird, and applies only to species commonly known as caged birds such as psittacines (birds in the parrot family), song birds, toucans, canaries, finches, cardinals, etc. The term does not apply to pigeons, doves, species of wild or domesticated fowl, or game birds.
