## Sri Lanka – Important Information Regarding Trade Bans and Other Restrictions

In light of COVID-19, Sri Lanka's Department of Animal Production and Health has issued restrictions on the importation of all animal products and by-products (e.g. meat and bone meal, bristles, hair, etc.) effective immediately. For any questions pertaining to these possible restrictions, it is recommended that the U.S. exporter work with their Sri Lankan importer to discuss the situation.

## Highly Pathogenic Avian Influenza (HPAI)

-Processed feathers and feather products - March 2024 (pdf 155kb) [note restrictions have been reduced from the state to the <u>county</u> level following re-negotiation of the new feather certificate] Reach out to your Service Center to determine the eligibility of the county of origin.

-<u>Veterinary Sanitary Certificate for the Export of Animal Products</u> (Other than Feathers) Not for Human Consumption - December 2005

Due to the detection of highly pathogenic avian influenza in various flocks in the states below, VS can no longer endorse the certificate for animal products other than feathers (regardless of species of origin) originating in the listed states.
