I, the undersigned veterinarian, hereby certify the animals listed above are intended for research and satisfy the following requirements:

1. The animals listed above were born and raised since birth in the facility listed above, and remained isolated from other animals not of equivalent health status. The animals have not been inoculated with any pathogens of infectious disease or parasites.

If eggs are being exported, then the broodstock population from which the eggs were derived, were born and raised since birth in the facility listed above, and remained isolated from other animals not of equivalent health status. The broodstock population have not been inoculated with any pathogens of infectious disease or parasites.

2. During the 12 months prior to export, there have been no clinical signs or other evidence of pathogens listed by the World Organisation for Animal Health (WOAH) or the pathogens of concern listed below in the exporting facility.

3. The facility monitors for the presence of the following pathogens of concern, and there have been no detections within 90 days prior to export. If there is suspicion of the following pathogens of concern, testing will be conducted at an approved laboratory with negative results prior to export.

For zebrafish (Danio rerio): Edwardsiella spp. and spring viremia of carp virus (SVC)

For killifish (from the Family Cyprinodontiformes): Streptococcus spp. and viral nervous necrosis (VNN)

4. The transport container and packaging are either new and unused or clean and disinfected. The water used for packaging or transportation is clean, and does not alter the animal's health status.

This certificate is valid for 10 days from the date of signature by the official veterinarian of the Competent Authority.
